KIIM-FM'S "ROAD TRIP TO CHIRS STAPLETON" CONTEST OFFICIAL RULES

The Station will conduct the **KiiM-FM's "Road Trip To Chris Stapleton"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the 180 days. Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. 2. Contest Period. The Contest entry period will begin at 6:00am MT on Monday, March 17, 2025 and will run through 11:59pm MT on Friday, March 28, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

4. <u>On-Air</u>: Listen to the Station weekdays between 6:00am and 9:00am MT Monday, March 17, 2025 through Wednesday, March 26, 2025. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 520-369-5446. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will receive the Qualifying Prize and be entered for a chance to win the Grand Prize. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

<u>Remote Broadcast & Text</u>: Attend a remote broadcast on Friday, March 28, 2025 between 10:00am and 12:00pm MT at The Southern Arizona Home Show at the Tucson Convention Center (260 S Church Ave, Tucson, AZ 85701), visit the Station's booth, and complete an entry form via text message by sending a text message with the posted keyword to 520-369-5446. All entries must be received by 11:59pm MT on Friday, March 28, 2025 to be eligible for the Grand Prize drawing. **Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive**

messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

- 5. **Winner Selection.** On or about 10:00am MT on Monday, March 31, 2025 Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within one (1) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
